1. Entries open to anyone.
2. No more than three steers and three heifers per exhibitor.
3. **Heifers will be shown by breed . BREED SPECIFIC HEIFERS MUST SHOW REGISTRATION CERTIFICATE. All other heifers will show as commercial heifers.**
4. Birth dates of Heifers must be provided.
5. Steers classes will be weighed, and determined by breed and weight. Heifer Class determined by breed and birth date.
6. Entry fee - \$20.00 per head. Fees for entries postmarked after May 30, 2011 will be \$30.00 per head.
7. No entries accepted without entry fee paid. **NO REFUNDS!** Make check payable to Aberdeen Area Chamber of Commerce.
8. **Unloading time NO EARLIER THAN 7:00 a.m., June 4, 2011 at Brown County Fairgrounds unless approved by show committee. SEE #13.**
9. Steers weighed and heifers entered between 9:00 -11:00 a.m. on Saturday, June 4, 2011.
10. All entries close at 11:00 a.m., June 4, 2011.
11. **Showtime immediately following Jr. No Fit Division, approximately 2:00 p.m., June 4, 2011.**
12. Fitting is optional. All entries are required to lead and tie.
13. **STEERS AND HEIFERS MUST BE PRESENTED BY A HEALTH CERTIFICATE PRIOR TO UNLOADING.** Heifers must be brucellosis vaccinated.
14. Grand Champion steer receives \$400.00 cash award. Reserve Champion receives \$200.00.*
15. Grand Champion heifer receives \$400.00 cash award. Reserve Champion receives \$200.00.*
16. All decisions of the show committee and judge are final.
17. Show committee and the Aberdeen Area Chamber of Commerce are not responsible for accidents.
18. Bedding, **wood chips only**, roughcuts will be provided. Other chips must be supplied by the exhibitor and all bedding removed at the conclusion of the show. **A \$20 STALL FEE PER ENTRY WILL BE ASSESSED DAY OF SHOW AND REFUNDED WHEN THE EXHIBITOR'S AREA IS CLEAN.**
19. **No fitting of animals or parking on the grass will be allowed.**
20. Concession stand will be available.
